Draft and advise on the contracts that are required for the US ODC to operate their businesses successfully and to protect their interests and exploit opportunities.</li><li>• Partner with US brand directors, Commercial state leads, HR &amp; Finance leaders (Key Stakeholders) in ensuring that they are kept abreast of any legal issues within their areas of responsibility and be their first port of call for legal input. Keep the Key Stakeholders up to date with any critical legal issues arising in the US and respond on a timely and efficient basis to Key Stakeholders with legal support.</li><li>• Support the legal compliance agenda in the US ODC ensuring that employees are aware of their obligations in this regard and that relevant training is carried out.
